Foreword

This Standard will replace GB/T 1019-1989.

Comparison with previous edition, main changes of this Standard are as follows:

After packaging the products that listed in the primary standard Annex, apply its test method into the standard files, and revise the main test methods as follows:

1) Packing case stacking test after hot flashes test, the height difference of packing case before and after the test changed from: "should less than 1.2cm/m" to "should less than 1.2cm/m".

2) Changed the impact speed in declivitous impact test from "v=2.2 m/s" to "v=1.5m/s".

3) Cancelled the "Crossrail Impact Test".

4) In the drop test, for those irreversible products, changed their base 3 from being dropped six times to three times.

5) The drop height range in the drop test was adjusted according to circulation condition one and two.

6) Added the chapter "Packing Mark".
