# National Food Safety Standard

## General Principles for Infant Formula Food for Special Medical

### Purpose

#### 1 Scope

This standard applies to special medical purpose infant formula food.

#### 2 Normative reference documents

Documents referenced in this standard are essential for the application of this standard. For reference documents dated, only the dated version is applicable to this standard. For reference documents without dated, its latest version (including all amendments) is applicable to this standard.

#### 3 Terms and definitions

##### 3.1 Baby

Refer to baby of 0 month to 12 months.

##### 3.2 Infant formula food for special medical purpose

Refer to powdered or liquid formula designed and prepared for the nutritional needs of special medical conditions infants suffering from specific disorders, diseases or medical conditions, etc.. Under the guidance of doctor or clinical nutritionist, when eating separately or together with other foods, its energy and nutrient can meet the growth and development needs for infants at the age of 0 month to 6 months in special medical conditions.

#### 4 Technical requirements

##### 4.1 General requirements

The formula of infant formula products for special medical purposes shall be based on the research result of medical science and nutritional science, its safety, nutritional adequacy and clinical effect shall be scientifically proven, when eating separately or together with other foods, it can meet the growth and development needs for infants at the age of 0 month to 6 months in special medical conditions.

The common categories and main technical requirements of special medical purpose infant formula food shall be in accordance with the regulations of Annex A of this standard. Special medical purpose formula food production conditions shall be in accordance with relevant state regulations.

##### 4.2 Material requirements

Raw materials used in special medical purpose formula food shall be in accordance with
