## Child-resistant packaging—Requirements and testing procedures for reclosable packages

#### 1 Scope

This Standard specifies the packaging requirements and testing procedures for reclosable packages designated as resistence to be opened by children.

This Standard is applicable to the reclosable packages designated as resistant to be opened by children (hereinafter referred to as child-resistant packaging)

#### 2 Terms and definitions

For the purposes of this Standard, the following terms and definitions apply.

#### 2.1

#### Container

Vessel of metal, glass, plastic or a combination of materials with a neck finish suitable for the proper attachment of a closure

#### 2.2

#### Closure

The container cap made of metal, plastic or a combination of materials with closure device..

#### 2.3

#### Child-resistant package

Package consisting of a container and appropriate closure which is difficult for young children under the age of fifty-two months to open, but which is not difficult for adults to use properly.
