## Foreword

This Standard is revision of SB 10021-2001 *Gelatinized confections*.

This Standard will replace SB 10021-2001 *Gelatinized confections*.

Comparison with SB 10021-2001 *Gelatinized confections*, main changes of this standard are as follows:

- Changed the SB 10021-2001 from mandatory professional standard to recommendatory professional standard;
- Added three types such as “covered, covered-polishing type”, “with filling type” and “other types”;
- Loss on drying (g/100):
  - Changed the gelatine type from 8.5~18.0 to  $\leq 18.0$ ;
  - Changed the animal glue type from 12.0~20.0 to  $\leq 20.0$ ;
  - Changed the amylan type from 8.0~18.0 to  $\leq 18.0$ ;
  - With filling type  $\leq 18.0$ , other types  $\leq 20.0$ ;
- Reducing sugar (by glucose, g/100): changed from  $\geq 19.0$  (gelatine type),  $\geq 18.0$  (animal glue type and mixed glue type),  $\geq 28.0$  (amylan type) to  $\geq 10.0$ .

## 1 Scope

This Standard specifies the product classification, technical requirements, inspection rules as well as marking, labeling, packaging, transportation and storage requirements for gelatinized confections.

This Standard is applicable to the producing, testing and marketing given in article 3.4 of SB 10346-2008.
