Foreword

Full text of this standard is mandatory.

This standard will replace GB 9678.1-1994 Hygienic standard for candy.

Comparison with GB 9678.1-1994, main changes of this standard are as follows:

- Revision of standard format according to GB/T 1.1-2000;
- Amendments have been made to the structure of the original standard, this Standard includes food additives, hygiene requirements for production and processing, packaging, labeling, storage, and transportation;
- Specifications for residual sulfur dioxide are added.

From implementation date of this standard, GB 9678.1-1994 shall be abolished.

This standard is proposed and under the jurisdiction of the Ministry of Health (MOH) of the People's Republic of China.

The drafting units for this Standard include: Shanghai Municipal Food Hygiene Inspection Center, Guangdong Province Food Hygiene Inspection Center, Shanghai Municipality Luwan District Food Hygiene and Epidemic Prevention Station, Heilongjiang Province Food Hygiene Inspection Center, Shanghai Guanshengyuan Food Manufacturers, Chongqing Municipal Food Hygiene and Epidemic Prevention Station.
