Introduction

The current national standard GB/T 12392—1990 Method for Determination of Total Ascorbic Acid in Fruits, Vegetables and Derived Products- Fluorometric Method and Colorimetric Method determine chlorination dehydrogenation ascorbic acid, and it can not determine reduced ascorbic acid of its main ingredients. In addition, it is limited to fruit and vegetable samples, and the operation is very complex. It is much more unsuitable for fortified food, protein food and other test samples. For this purpose, standard test method is developed for determine the ascorbic acid in food. This method is characterized by high sensitivity, good accuracy, easy and simply operation, fastness, wide usage, etc. It is applicable to the determination of the ascorbic acid of various kinds of food.
