Standard for pollution control on hazardous waste storage

1 Subject and Application Range

1.1 Subject

The standard stipulates general requirements of Hazardous Waste Storage and the requirements of packing, site selection, designing, operation, safety protection, monitoring and closedown of storage facilities.

1.2 Application Range

The standard is suitable for the pollution control and supervision management of all hazardous wastes (except gangues) and the producer as well as manager of hazardous waste.
