Foreword

Article 3.1 and 8.1 of this Standard are mandatory provisions, and the rest are recommendatory provisions.

This standard substitutes GB 4927—2001 Beer

This standard, in comparison with GB 4927-2001, has the main changes as follows:

- ——The definition of special beer is adjusted to Chapter Three Terms and Definitions, in which the definitions of dry beer, ice beer, low-alcohol beer, wheat beer, and turbid beer are changed and the definitions of non-alcohol beer and fruit and vegetable beers are added:
 - ----Added product classification;
 - —The negative deviation of net content is changed into net content;
 - ——Quality grade II is cancelled;
- ——The unit of measurement for alcohol content is converted to be indicate with volume fraction (%vol);
- ——The foam stability, alcohol content, original wort concentration, total acid and carbon dioxide indexes of the pale beers are adjusted;
- ——The foam stability, alcohol content, original wort concentration and carbon dioxide indexes of the brown beers and dark beers are also adjusted with the addition of the requirements on activity of invertase.
 - ——Appropriate changes are made to the ex-factory inspection items.
