This Standard is corresponding to ISO 2575: 2000/Amd.4: 2001 *Road vehicles - Symbols for controls, indicators and tell-tales*, JEVS Z804: 1998 *Symbols for controls, indicators and tell-tales for electromobile*. This Standard is not equivalent to ISO 2575 and JEVS Z804.

This Standard is supplement to GB 4094 *Motor vehicles—Symbols for controls, indicators and tell-tales*. Electric vehicle is part of automobile, shall meet the requirements of GB 4094 on symbols for controls, indicators and tell-tales, which as shown in this Standard.

This Standard is recommended national standard, this Standard is applicable to symbols for controls, indicators and tell-tales of electric vehicle.

This Standard was proposed by NDRC (National Development and Reform Committee).

Electric vehicles – Symbols for controls, indicators and tell-tales

1 Scope

This standard specifies basic requirements for electric vehicle, regarding to symbols for controls, indicators and tell-tales, and colors for tell-tales. (see GB/T 19596-2004).

This Standard is applicable to electric vehicles.

3 Terms and Definitions

For the purpose of GB/T 4782 and GB/T 19596, following terms and definitions of this Standard shall apply.

4 Requirements

4.1 The form of symbols and display color of tell-tales which only apply to controls, indicator and tell-tales of electric vehicles shall be in accordance with this Standard.

4.2 Other requirements of symbols shall be in accordance with GB 4094.

5 Categories of Symbols and Display Color of Tell-tales

Categories of symbols and display color of tell-tales indicator see Table 1.

6 Form of Symbols

Form of symbols which only apply to controls, indicator and tell-tales of electric vehicles see Figure 1 to Figure 10.
