Foreword

This Standard replaces the GB 13432-2004 General Standard for the Labeling of Prepackaged Foods for Special Dietary Uses.

Compared with GB 13432-2004, this Standard mainly has the following changes:

-----Modified the name of the Standard;

——Modified the definition of foods for special dietary uses, and made clear the food categories (range) it containing;

-----Modified the basic requirements;

-----Modified part of the requirements of the mandatory marking contents;

——Merged the allowable marking contents and the recommended labeling contents, and modified them to be the optional labeling contents;

- -----Modified the content claims requirements of energy and nutritional ingredients;
- -----Deleted the comparative claims of energy and nutritional ingredients;
- -----Modified the terms for function claims of energy and nutritional ingredients;

-----Deleted the original Standard Annex A;

-----Added the categories of the foods for special dietary uses in Annex A.

National Standard of Food Safety

Labeling of Prepackaged for Special Dietary Uses

1 Scope

This Standard applies to the labeling of the prepackaged foods for special dietary uses (including nutrition labeling).

2 Terms and definitions

For the purpose of this Standard, the following terms and definitions and those specified in GB 7718 apply.

2.1 Foods for special dietary uses

The foods with specialized processing or formulations in order to meet the special physical or physiological conditions and (or) to meet the special dietary requirements in the state of diseases, disorders and other states. The contents of the nutrients and (or) other nutritional ingredients of such kind of foods can be significantly different from that of the analogous ordinary foods.

The food categories contained in the foods for special dietary uses are shown in Annex A.

2.2 Nutrients

The food has a specific physiological function, which can maintain the needed substances of the growth, development, activity, reproduction and normal metabolism of body, including proteins, fats, carbohydrates, minerals and vitamins, etc.

2.3 Nutritional ingredients

The nutrients and the other food components with the nutritional function and (or) physiological function in addition to the nutrients in the foods.

2.4 Recommended nutrient intake

The nutrient intake level which can meet the needs of vast majority of the individuals in a group with particular gender, age and physical condition;

2.5 Adequate Intake

A safe intake level of nutrients; it refers to the intake of certain nutrients of healthy population obtained by observation or experiment.
