This standard will be implemented from October 1, 2004. The transition period of implementation for products produced before October 1, 2004 is one year.

6: Furniture

1 Scope

This part of GB 5296 specifies the basic requirements, methods and the required contents for compiling instructions for use of furniture.

This Part is applicable to the compilation of instructions for use of various furniture.

2 Normative References

The following normative documents contain provisions which, through reference in this part of GB 5296, constitute provisions of this part. For dated reference, subsequent amendments (excluding corrigendum content) to, or revisions of, any of these publications do not apply. However, parties that enter into an agreement according to this standard are encouraged to study whether the latest edition of these documents can be used. For any undated references, the latest edition of the normative document referred to applies.

GB 5296.1-1997 Instructions for Use of Products of Consumer Interest - General Principles

3 Basic Requirements

- **3.1** Furniture on sale must be attached with instructions for use (labels, nameplates, instructions for use, etc.).
- **3.2** The name of the furniture must reflect the actual attribute of the furniture and comply with the specified of national standards or professional standards. For the furniture, whose name is not specified in the national standards and professional standards, the common name in the furniture industry shall be used.
- **3.3** The instructions for use must clearly specify the furniture function and the applicable environment conditions; meanwhile, it shall provide the structure, materials, performance, type, specifications as well as the methods, requirements and required diagram for correct transport, installation, use, and maintenance. The details are given in Appendix A.
- **3.4** The furniture on sale must comply with relevant national laws and regulations and standard provision on safety, health and environmental protection. The
