## Foreword

Full text of this Standard is mandatory.

This national standard will replace and abolish GB 2707-1994 *Hygienic standard for frozen pork* and GB 2708-1994 *Hygienic standard of beef, mutton and rabbit meat*.

Comparison with GB 2707-1994 and GB 2708-1994, main changes of this Standard are as follows:

- The format of full text has been revised according to GB/T 1.1-2000;
- Combined GB 2707-1994 and GB 2708-1994 into this Standard as per category and enlarged the application range of Standard;
- The structural of GB 2707-1994 and GB 2708-1994 has been revised and added raw material, food additive, manufacturing and processing as well as hygienic requirements for packaging, transportation and storage;
- Added the limited requirements for Pb, AsIII, HgT, Cd and pesticide residue requirements;
- Changed the limitation of total volatile basic as  $\leq 15\text{mg}/100\text{g}$ .

This Standard will be implemented on Oct 01, 2005, the transitional period is one year. i.e. the products which manufactured before Oct 01, 2005 and accord with relevant standards, sell to Sept 30, 2006 is allowed.

This standard is proposed and governed by Ministry of Health of the People's Republic of China.
