**Notice of Approval on Issue of *Code for Acceptance of
Construction Quality of Masonry Engineering***

J. B. [2002] No. 59

As per the demand of *Notice on Issue of Formulation and Revision Plan of State Code for Construction 2000 to 2001* (J. B. [2001] No. 87), the Department of Development of Shanxi Province has jointly revised *Code for Acceptance of Construction Quality of Masonry Engineering*. We have carried out inspection with certain authorities and hereby approve as the state code, serial number as GB50203-2002, implemented from April 1, 2002. In which, clauses 4.0.1, 4.0.8, 5.2.1, 5.2.3, 6.1.2, 6.1.7, 6.1.9, 6.2.1, 6.2.3, 7.1.9, 7.2.1, 8.2.1, 8.2.2, and 10.0.4 are obligatory that have to be carried out strictly. The original *Code for Acceptance of Construction Quality of Masonry Engineering* GB50203-98 abolishes at the same time.

The Ministry of Construction will be responsible for the management and explanation on the obligatory clauses. The Administration of Construction of Shanxi Province will be responsible for the explanation on the detailed technical contents, and the Standard Ration Research Institute of the Ministry of Construction will organize the China Planning Publishing House to issue the publication.

1 General principles

- 1.0.1 To tighten to quality control of the construction engineering, unify the inspection and acceptance of the construction quality of masonry engineering and to guarantee the quality of the whole engineering, this code is hereby formulated.
- 1.0.2 This code is suitable for the construction quality control and acceptance of the bricks, stones, concrete small-size hollow bricks, and evaporized and pressurized concrete bricks.
- 1.0.3 This code is accomplished with the state standard *Unified Code for acceptance of construction quality of construction engineering* GB50300-2001.
- 1.0.4 The requirement of the construction quality specified in the technical documents and contracts should not be lower than in this code.
- 1.0.5 The acceptance requirement of the masonry engineering not only should accord with this code, but also should accord with the current state code.
