# Road vehicle-Plate and label

## 1 Scope

This Standard specifies the definition, characteristic requirements and test methods of plates and labels used on the vehicle on the road for describing vehicle's information.

This Standard applies to various types of plates and labels used on the vehicle on the road for describing vehicle's manufacturing information, warning information, operation and indicative information and other contents.

This Standard does not apply to the vehicle label directly formed by being engraved, etched, cast, sprayed, printed, sewn directly or other methods on vehicle or vehicle part body.

This Standard does not apply to non-informational plates and labels of vehicles.

This Standard does not apply to the vehicle or part label used in vehicle production, transportation and transfer (can be removed before the normal use of vehicle).

All kinds of plates and labels for vehicle parts and assemblies can be adopted by reference
