Foreword

This standard is the revision of GB/T 4789.21-1994 “*Microbiological examination of food hygiene-Examination of cold drinks*”

Comparison with GB/T 4789.21-1994, main changes of this Standard are as follows:

- Reclassified the cold drinks specified in this Standard according to new food hygiene standard;
- Changed the standard name as *Microbiological examination of food hygiene-Examination of cold drinks*;
- Changed the “this standard specifies the test methods for cold drinks” and “this standard is applicable to the examination of frozen drinks and cold drinks” in previous standard as “This standard specifies the testing method for frozen drinks and beverage”.
- The format of standard text and the characters were amended according to GB/T 1.1-2000.
- The "Equipments and Materials" in the previous edition was amended and normalized.
- The “Referenced standard” was amended and normalized.
- Changed the contents of operation procedures.

GB/T 4789.21-1994 shall be abolished simultaneously from the implementation date of this standard.

This standard was proposed by and is under the jurisdiction of the Ministry of Health of the People's Republic of China.

Chief drafting organizations of this standard: Beijing Epidemic Prevention Station and Chinese Center for Disease Control and Prevention Nutrition and Food Security.

Chief drafting staffs: Liu Yixian, Fu Ping, Ji Rong, Yang Baolan and Yao Jinghui.

This standard was issued for the first time in 1984, revised for the first time in 1994 and revised now for the second time.
