Foreword

This standard was drafted in accordance with GB/T 1.1-2009.

This standard replaces SB/T 10373 - 2004, Collagen casings.

For the purpose of this standard, the main differences between this standard and the SB/T 10373-2004 are as follows:

- The requirements for the auxiliary materials of the raw materials are independently specified.
- The chemical and physical indicators and hygienic indicators for the product quality are respectively specified and the requirements for grading are deleted.
- The determination for compression strength and longitudinal anti-breaking force in the original standard are adapted.
- The requirements for deviation of the actual casing length are changed to comply with JJF 1070.
- With respect to the items of inspection in the factory, the requirements for coliform group are added.
- For the criterion rules of the inspection in the factory and the type inspection, the requirements for relevant microbe indicators are added.

1 Scope

This standard specifies the collagen casings terms and definitions, raw and auxiliary materials, technical requirements, inspection method, inspection rules, labeling, packaging, transportation, and storage, and recall requirements.
