3 Terms and Definitions

For the purpose of this standard, the following terms and definitions apply.

3.1

Maltodextrin (MD)

It refers to the starch derivative without free starch, which is made from starch or starchiness through low degree enzymatic hydrolysis, refining and spray drying.

4 Products Classification

The products are classified into three classes according to DE values, including MD10, MD15 and MD20.
