Foreword

This Standard is drafted according to the rules specified in GB/T 1.1-2009.

This Standard replaces HG/T 2525-1993 – *The Insoluble Sulfur for Rubber* Compared with HG/T 2525-1993, the main technical changes are as follows in addition to editorial changes:

- It deletes the requirements on products of Model IS 70-20 and Model IS 60-33, and adds the requirements on products of Model IS-HS 70-20 and Model IS-HS 60-33 (see Chapter 3, and Chapter 4 of Edition 1993);
- It modifies the requirements of different types of products for testing items (see Chapter 3, Chapter 4 of Edition 1993)
- It modifies the indicator value of the mass fraction of residue on sieve (150μm) inside the insoluble sulfur for rubber (see Chapter 3, Chapter 4 of Edition 1993);
- It adds the requirements and test methods for the heat stability (105°C) of insoluble sulfur for rubber (see Chapters 3 and 4.6).

This Standard is proposed by China Petroleum and Chemical Industry Federation.

This Standard is under the jurisdiction of Branch Technical Committee of Sulfur and Sulfuric Acid for the National Standardization Technical Committee of Chemical (SAC/TC63/SC7).

1 Scope
