Foreword

This Standard is an amendment to GB8108-1987 according to the provisions of GB/T1.1-1993 *Directives for the Work of Standardization. Unit 1: Drafting and Presentation of Standards Part 1: General Rules for Preparing Standards* and GB/T1.3-1997 *Directives for the Work of Standardization. Unit 1: Drafting and Presentation of Standards Part 3: Rules for Preparing Product Standard*.

Compared with GB8108-1987, the amendments of this Standard are shown as follows:

Modified the standard structure, technical elements and presentation rules according to GB/T1.1-1993 and GB/T1.3-1997.

Added the articles such as referenced standard, definition, classification, inspection rules, marking, packaging, transport and storage.

In actual use of sirens, there are several new tones widely used, and this Standard specifies the frequency, modulation cycle and scope of application of such tones.

Added the technical requirements for microphone and speaker, and developed test method.

According to actual use of the product as required, this Standard has also made some changes on requirements for sound pressure level and environment test conditions of sirens.

Since six months after the implementation of this Standard, all vehicle-used electronic sirens must meet the requirements of this Standard.

It replaced the GB8108-1987 simultaneously on the date of implementation of this Standard.

This Standard is proposed by the Ministry of Public Security of the People's Republic of China.

This Standard is under the jurisdiction of Traffic Management Bureau of Ministry of Public Security.

The Standard is drafted by Traffic Management Research Institute of the Ministry of Public Security.

The main drafters of this Standard are: Wei Guangsong, Bao Yongqiang and Yu Lieying.

This Standard was first issued in July 1987 and first revised in August 1999.
