Foreword

GB/T 16716 Packaging and Packaging Waste is totally divided into seven parts:

- —Part 1: General rules of disposal and utilization;
- -Part 2: Assessment methods and procedures;
- —Part 3: Reduce dosage in advance;
- —Part 4: Reuse;
- —Part 5: Materials recycling;
- -Part 6: Energy recovery;
- —Part 7: Biodegradation and compost.

The Part is Part 1 of GB/T 16716.

The main technical content of the Part is formulated by reference to EU 94/62/EC *Packaging and Packaging Waste*; the established terms and specified heavy metal content index in the Part are identical to that of 94/62/EC. Main technical differences between the Part and 94/62/EC are as follows:

- —Changed the formatting and presentation applicable to EU regulations to the formatting and presentation applicable to our standard;
- —Without specific provisions on recycling rate and recovery rate of various packaging materials;
- —Changed the incineration instruction and refuse landfill instruction referenced by the Directive to the corresponding mandatory standard of our country.

The Part has replaced the GB/T 16716-1996 *General Rules of Disposal and Utilization of Packaging Waste*.

The Part, in comparison with GB/T 16716—1996 mainly have the following changes:

- —Deleted Chapter 4, "Category" in the original standard;
- —Chapter 5, "Basic Requirements" in the original standard was changed to Chapter 4, "Requirements" in the Part, including basic requirements, reuse, recovery and final disposal;
- —Deleted Chapter 9, "Storage and Transportation" in the original standard.

The Part is proposed by the Standardization Administration of the People's Republic of China.

The Part is under jurisdiction of the National Packaging Standardization Technical Committee.

China National Export Commodities Packaging Research Institute is responsible for drafting the Part; Shanghai Food and Drug Packaging Material Control Center, Huawei Technologies Co., Ltd., Sichuan Changhong Electric Co., Ltd. and Beijing Entry-Exit Inspection and Quarantine Bureau participate in the drafting.

Main drafters of the Part: Xian Yongli, Wang Yuande, Xu Minfeng, Cai Gang, Tang Shutian, Guo Zhenmei.

The issuance condition of the standard previous versions replaced by the Part is:
