In order to implement "Environment Law of the People's Republic of China", "Atmospheric Pollution Prevention Law of the People's Republic of China" and "Water Pollution Prevention Law of the People's Republic of China", prevent and remedy pollution as well as protect the environment and human health, now "discharge standard of atmospheric pollutants for cement industry" and others, totally four standards have been approved as national discharge (control) standards of pollutants and have been jointly issued by the Ministry of Environmental Protection and General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China.

Name and number of the standards are as follows:

1. Discharge standard of atmospheric pollutants for cement industry (GB 4915 - 2013);
2. Control standard of cement kiln co-processing solid waste pollution (GB 30485 - 2013);
3. Discharge standard of pollutants for battery industry (GB 30484 - 2013);
4. Discharge standard of water pollutants for leather and fur making industry (GB 30486 - 2013).

According to regulations of related laws, above standards are with compulsory execution effect.

Above standards shall be implemented since March 1, 2014.

Above standards are issued by China Environment Press and the content of the standards can be inquired on the website of the Ministry of Environmental Protection (bz.mep.gov.cn).

New facilities and existing facilities shall stop implementing "discharge standard of atmospheric pollutants for cement industry" (GB 4915 - 2004) separately since March 1, 2014 and July 1, 2014.

Foreword

In order to implement “Environment Law of the People’s Republic of China”, “Water Pollution Prevention Law of the People’s Republic of China”, “Marine Environment Protection Law of the People’s Republic of China”, and other laws and regulations, protect the environment, prevent and remedy pollution as well as promote the progress of manufacturing technique and pollution abatement technology of leather and fur making enterprises, this Standard is formulated.

This Standard specifies limiting value, monitoring and supervisory control requirements on discharge of water pollutants for leather and fur making enterprises, as well as special limiting discharge value of water pollutants in key areas. Discharge of atmospheric pollutants (including odor pollutants) and ambient noise of leather and fur making enterprises applies to corresponding national discharge standard of pollutants, while identification, dispose and treatment of solid waste produced by leather and fur making enterprises applies to national control standard of solid waste pollutants.

This Standard is issued for the first time.

New facilities and existing facilities of leather and fur making enterprises shall control discharge of their water pollutants according to regulations of this Standard and no longer implement related regulations of “integrated wastewater discharge standard” (GB 8978 - 1996) separately since March 1, 2014 and July 1, 2014.

This Standard is the basic requirements for discharge and control of water pollutants of leather making industry. For pollutants unstated in this Standard, regional people’s governments at the provincial level can formulate regional discharge standard of pollutants; for pollutants stated in this Standard, regional discharge standard of pollutants stricter than this Standard can be formulated. When the requirements of environmental impact assessment statements are stricter than this Standard or regional standard, the approved environmental impact assessment statements shall be implemented.

This Standard was drawn up by organization of Science and Technology Standard Department of Ministry of Environmental Protection.

The responsible drafting organizations are China Leather Association, China Cleaner Production Center of Light Industry and Research Institute of Environmental Standards of Ministry of Environmental Protection.

This Standard was approved by the Ministry of Environmental Protection on December 16, 2013.

This Standard shall be implemented since March 1, 2014.

This Standard shall be explained by the Ministry of Environmental Protection.

Discharge standard of water pollutants for leather and fur making industry

1 Scope

This standard specifies limiting value, monitoring and supervisory control requirements on discharge of water pollutants for leather and fur making enterprises, as well as related regulations on implementation of this standard and supervision, etc.

This standard applies to the discharge management of water pollutants for existing leather and fur making enterprises.

This standard applies to the discharge management of water pollutants for construction projects of leather and fur making enterprises during environmental impact assessment, design of environmentally protective facilities, environmental protecting acceptance check and production.

This standard applies to the discharge behavior of water pollutants allowed by laws; site selection of newly established pollution sources and management of existing pollution sources in special protection areas shall be implemented according to related regulations of “Water Pollution Prevention Law of the People’s Republic of China”, “Marine Environment Protection Law of the People’s Republic of China”, “Environmental Impact Assessment Law of the People’s Republic of China” and other laws, regulations and rules.

The requirements on discharge and control of water pollutants regulated in this standard apply to the behavior that enterprises directly or indirectly discharge water pollutants outside their legal boundary.
