- Content on facial tissue has been deleted;
- Terms and definitions, as well as classification have been added;
- Indexes of portable fluorescent whitening agent, sealability of packaging, pH,
   detergency and causticity have been added;
- Regulation on packaged quantity has been adjusted;
- Liquid content, horizontal tensile strength, dirt count and other indexes have been adjusted;
- The assay method for liquid content has been modified.

#### 1 Scope

This standard specifies classifications, requirements, test method, inspection rules, marking and packaging as well as transportation and storage of wet wipes.
