Food Additive Vanillin

1. Scope

This standard stipulates the requirements, test methods, inspection rules, mark, packing,

transportation, storage and quality guarantee period for food additive vanillin.

This standard is applied to analyze and evaluate the quality of food additive—vanillin,

which takes guaiacol or lignosulfite as the raw material and is made by chemical

synthesis.
