Boiler Service Administration Regulation 锅炉使用管理规则

Promulgated by General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China September 15, 2014

Foreword

In June, 2011, General Administration of Quality Supervision, Inspection and Quarantine (hereinafter referred to as AQSIQ) Special Equipment Safety Supervision Bureau (hereinafter referred to as Special Equipment Bureau) assigned "Boiler Service Administration Regulation" drafting task to China Special Equipment Inspection and Research Institute (hereinafter referred to as CSEI), In August, 2011, CSEI organized a drafting group, which convened the first working conference in Beijing and determined "Boiler Service Administration Regulation" development principals, general framework, main contents, drafting work division, time scheduling, etc.

In March, 2013, drafting group convened the second working conference in Beijing and revised to form exposure draft of "Boiler Service Administration Regulation" through discussion. In June, 2013, Special Equipment Bureau asked for opinions from departments of basic level through Zhi Jian Te Han [2013] No. 32 document and asked for opinions on line from society. According to these opinions, drafting group revised to form draft for examination. In August, 2013, draft for examination was submitted to AQSIQ Special Equipment Safety Technical Committee for review. It was revised to form draft for approval. On September 5, 2014, the Regulation was approved and promulgated by AQSIQ.

This Regulation follows the requirements of "Special Equipment Safety Law of the People's Republic of China", "Regulation on Special Equipments Safety Supervision" and "Boiler Safety Technical Supervision Administration Regulation" (TSGG0001), reflects the guiding ideology of implementing responsibilities of all parties and classified supervision, takes into account the current characteristics of units with boiler property right, increases the requirements of for self-inspection of boiler using unit, proposes specific requirements for boiler use safety to guide and regulate use administration work.

Boiler Service Administration Regulation Chapter I General Provisions

Article 1 In order to standardize boiler service administration and guarantee safe and economical operation of boilers, this Regulation is hereby developed according to "Special Equipment Safety Law of the People's Republic of China" and "Regulation on Special Equipments Safety Supervision".

Article 2 This Regulation applies to boiler service administration within the scope of "Special Equipment Safety Law of the People's Republic of China".

Article 3 Boiler using unit (hereinafter referred to as using unit) shall conduct safety and energy-saving administration according to provisions of this Regulation and handle boiler use registration and get "Special Equipment Use Registration Certificate" (see annex A for format, hereinafter referred to as "Use Registration Certificate").

Article 4 Using unit shall be responsible for boiler use safety and energy efficiency.

Article 5 General Administration of Quality Supervision, Inspection and Quarantine (hereinafter referred to as AQSIQ) is responsible for safety supervision and energy-saving supervision of boilers used all over the country; local quality and technology supervision department of county level above is responsible for safety supervision and energy-saving supervision of boilers used in the administrative region. Quality and technology supervision department of municipality level or of city divided into districts is responsible for use registration of boilers used in the administrative region.

Chapter II Use Safety Administration

Article 6 Main responsibilities of using units are as follows:

(I) Setting up safety administration organization according to requirements of this rule, allocate full-time and part-time safety administration personnel;

(II) Establishing and effectively implementing system of post responsibility, operation code, hidden danger handling, energy-saving administration, emergency rescue, personnel training administration, procurement acceptance inspection and other safety administration systems;

(III) Regularly convening boiler service safety administration conference; supervising and

inspecting boiler safety work;

(IV) Guaranteeing necessary boiler safety and energy-saving input.

Article 7 Safety administration personnel shall have corresponding certificate for special equipment safety administration personnel; the main responsibilities are as follows:

(I) Implementing relevant laws, regulations and safety technical specification; organizing the preparation and timely updating boiler use safety and energy-saving administration system;

(II) Organizing the preparation of code for boiler safety operation;

(III) Organizing safety education and safety technical training;

(IV) Organizing boiler acceptance inspection, handling boiler use registration and change procedures;

(V) Establishing boiler safety and energy-saving technical files;

(VI) Organizing regular self-inspection work of boiler;

(VII) Organizing preparation of boiler accident emergency special plan and organizing drill;

(VIII) Organizing and participating in boiler accident rescue according to the provisions of boiler accident emergency special plan;

(IX) Preparing regular inspection plan of boiler and implementing regular inspection, organizing rectification for problems discovered during regular inspection;

(X) Conducting regular inspections, handling immediately in case of any problem discovered; make decision to stop using boiler in case of emergency and reporting to relevant principal of the unit;

(XI) Reporting boiler accidents in accordance with provisions; cooperating accident investigation and after-treatment.

(XII) Correcting and putting an end to behaviors of boiler operation personnel in violation of regulations;

(XIII) Cooperating with quality technical supervision department on safety supervision and energy-saving inspection;

Article 8 Boiler operation personnel shall have corresponding certificate for special equipment operation personnel, main responsibilities of whom are as follows:
