1 Scope

This standard specifies the definition of propolis and ethanol extracted propolis, as well as requirements for its quality, test method, packaging, labeling, storage and transportation. This standard is applicable to the process and trade of propolis and ethanol extracted propolis.

3 Terms and definitions

For the purpose of this standard, the following terms and definitions shall apply..

3.1

Propolis

Adhesive substance that the secretions of plant resins collected by worker bees are mixed with the secretions from their mandibular gland and wax gland

3.2

Ethanol extracted propolis

Substance that is obtained after using ethanol to extract the propolis

3.3

Total flavonoids

Sum of flavonoid contents

4 Requirements

4.1 Sensory requirements

4.1.1 Sensory requirements of the propolis should comply with the provisions in Table 1.
