# Safety technical code for infants and children textile products

#### 1 Scope

This Standard stipulates provisions of safety technical requirement, testing method and inspection rule of infants and children textile products.

This Standard is applicable to infants and children textile products sold within our borders. Note: fabrics and stuffed toys, cloth crafts, disposable hygienic products, luggage, handbag and knapsack, umbrella, carpet and professional sportswear are all beyond the applicable range of this Standard.
